# Instructor Registration - Online (VPK 11A)

For a credentialed VPK Instructor (Lead Teacher): Class cannot exceed 11 students with one instructor. An AIDE/Assistant teacher is required if there is an increase of children in the class from 12 to 20 with 20 being the max number of children in the VPK classroom

All providers must adhere to their classroom ratio based on DCF Licensing or Accrediting Agency ratio guidelines. Example: If the classroom capacity is 15, there can be no more than 15 students in the VPK class.

Florida's Childcare Professional Certificate (FCCPC) or National CDA (NECC) The ELC of Orange County will no longer accept copies of certificates as proof of credentials for Lead instructors. Please submit the instructor's DCF training transcript and staff credential as verification that the instructor is eligible to be the Lead in the VPK classroom during the school year.   - Forms are good for 5 years
  - For instructors hired after May 2019, revised Attestation of Good Moral Character must be completed (does not have to be notarized, but must be signed by a witness)
  - ❖ For each Secondary VPK Instructor (Aide/Assistant/substitute Instructors), no credentials are needed. Must have background clearance and Affidavit of Good Moral Character
  - ❖ Substitutes must have the same qualifying credentials if acting as the Lead instructor in the VPK class for more than 30% of the VPK class hours)

#### **Additional Notes**

#### Ratio:

1 instructor (lead) = 11 children

2 instructors (lead and aide) = 12 to 20 children

All providers must adhere to their classroom ratio based on DCF Licensing or Accrediting Agency ratio guidelines. Example: If the classroom capacity is 15, there can be no more than 15 students in the VPK class.

## Class Registration – Online (VPK 11B)

## **Program Dates:**

VPK program cannot begin before the first day of Orange County Public School's start date which is **August 10**. **2023** 

Must have a minimum of 4 VPK eligible children to begin the VPK class

VPK program has until **<u>Iune 30, 2024</u>** to provide 540 instructional hours

- Program cannot offer more than or less than 540 hours
- Must offer a minimum of 3 hours per day

Once all documentation has been uploaded and the profile is shown as "Active", you will receive two contracts (VPK 20 and VPK App -10, 11A 11B) to complete
