Scenario 6: Effective and Expiration Dates

Upon completion of the emergent literacy course requirements, participants will receive a **YES** on their training transcript along with **effective** and **expiration dates**.

Each VPK teacher is required to take one 5-hour emergent literacy course every 5 years following the initial 15-hour/three 5-hour course requirement.

The expiration date will typically display a 5-year span from the effective date, but in some cases, the expiration date may display 10 years from the effective date.

The transcript below illustrates the completion of the required 15 hours/three 5-hours of training and the completion of the additional 5 hours which has been applied to the expiration date.

The **VPK Directors Endorsement** is noted on the participant's transcript under the *Special Certifications and Credentials* section. The VPK Director's Endorsement **does not** have an expiration date and would ONLY appear on the transcript if the participant has completed all the required trainings.

While the illustration below identifies the VPK Director Endorsement and the Director Credential Renewal on two separate lines, they both are valid and apply to the current program year.
